- **A Report of Birth and related documents may be filed in person or by mail. Submissions by mail are subject to additional requirements as noted below. The Consulate will NOT process an application unless all requirements are complete.**
- **All documents must be in English or accompanied by an official English translation. International versions of German civil registry documents with built-in English translation are preferred.**
- **Original documents from the Philippines should be issued by the Philippine Statistics Authority (PSA).**
- **The Consulate may require additional documents from the applicant depending on the circumstances of the application.**

<input type="checkbox"/> JOINT AFFIDAVIT OF LEGITIMATION (applicable only if the parents were subsequently married after the child's birth). If filing by mail, the Affidavit must be notarized by a German Notar and authenticated by the Landgericht.	4 originally-signed Affidavits
<input type="checkbox"/> AFFIDAVIT OF ACKNOWLEDGMENT OF PATERNITY (to be executed by the father of the child). If filing by mail, the Affidavit must be notarized by a German Notar and authenticated by the Landgericht.	4 originally-signed Affidavits
<input type="checkbox"/> AFFIDAVIT TO USE THE SURNAME OF THE FATHER (to be executed based on the following conditions during the time of the application of the Report of Birth): <ul style="list-style-type: none"> • For applicants 0-6 years of age - to be executed by the mother/guardian • For applicants 7-17 years of age - to be executed by the child plus Sworn Attestation of mother/guardian • For applicants 18 years of age and above - the applicant will execute the Affidavit.
